One of the changes is that the Advisory Council needs to add a representative of an alternative financing program, and the Adult Services Division. 50% of our reps need to be users of AT or caregivers of persons who use AT. We filed our 4-year state plan with the Administration for Community Living (ACL). We are on track to meet our objectives. A requirement of 5% of our spending threshold on Transition activities includes transition from high school to post-secondary or transitioning from higher level of care to independent living.
