The AT Program held a retreat at VINS in Quechee, VT it is a physically accessible outdoor space that features a forest canopy walk. The team was able to see the positive accessibility features as well as consider suggestions such as improved signage for visual

disabilities. Priorities and mission for upcoming year; apply for the October [Christopher Reeve grant](#), equipment review at all locations, and implementation of iPad mobile device management (MDM) to more efficiently provide enhanced security and client use.

Adding a half time AT consultant to support services for HireAbility clients. VT Career Advancement Project (VCAP) has made a commitment to use AT services, we are seeing double the number of cases coming in for this program. VCAP is a 5-year research grant to help clients gain credentials and careers. Each of the 10 HA offices has at least one VCAP counselor to refer to these cases to the AT Program. The AT Program currently has one staff member taking these cases.

We are considering shipping loans from one location to all parts of the state and regions covered and bringing in help to free AT Specialist's time.
